CALL TO ORDER: Robin Rich-Coates, Chair, called to order the March 2, 2022 Special Called District Board Meeting of the Eastern Shore Soil and Water Conservation District.

NEW BUSINESS:

FY20 Contract Increases for Approval using new FY22 Average Cost List- Carmie Savage:

Carmie presented to the Board the increases/decreases in funding that would affect the approved FY20 Carryover Poultry projects using the approved FY22 District Average Cost List (ACL) to estimate the costs. The VA Soil and Water Board approved to allow individual Districts to recalculate the original estimated costs based on their individual FY22 ACL due to the rise in lumber/costs if individual Boards chose to do so. Since the FY20 estimates were based using FY20 NRCS' ACL, the Litter Shed estimates increased using the new ACL but the composters decreased due to the extremely inflated costs used in FY20 NRCS' ACL. Since then, NRCS' most current ACL is more in-line with actual costs for constructing composters. For the six (6) FY20 Carryover VACS funded projects, the difference between the FY20 Ches Bay VACS estimates and the FY22 Ches Bay VACS estimates using the new ACL totaled an increase of \$360,230.65 and a decrease of \$68,383.64. The FY20 OCB VACS estimates totaled an increase of \$95,303.75 and a decrease of \$60,375.06.

The increase of \$360,230.65 in Ches Bay contracts (contracts 20-20-0170 instance 378612, 20-20-185 instance 379662, 20-20-0206 instance 389615, 20-20-0164 instance 377886) would be funded using 100% of the unallocated balance left in the District's FY22 Ches Bay allocation totaling \$187,013.07 and the transfer of unallocated Ches Bay funds

from another District(s). There is potentially another District willing to transfer the needed Ches Bay funds to the Eastern Shore SWCD from their unallocated balance. Considering funding the increases would wipe out the FY22 Ches Bay VACS funds, the request for transfer could be rounded up to \$200,000 instead of the \$173,217.58 needed in case any last minute Ches Bay cost share requests come into the District.

After the transfer of \$250,000 OCB VACS funds from James River SWCD, the District still needs \$129,472.76 to fully fund the OCB cost share requests. There is \$167,208.64 in the District's FY22 Operational Budget line item "Cost Share Support" that could be used to fully fund the requests. That would leave a balance of \$37,735.88 in that "Cost Share Support" line item. The increase of \$95,303.75 in the one OCB contract (20-20-0175 instance 378741) could be funded using that balance of \$37,735.88 and \$57,567.87 from the District's Designated funds that are designated for "projects related to soil and water conservation on the Eastern Shore". Those available designated funds total \$298,008.96 which would more than cover the \$57,567.87 needed leaving a balance of \$240,441.09.

The one FY21 approved contract 20-21-0176, instance 426648, the District approved to fund using local funds (FY20 VNRCF TA). That project increase is \$115,151.22 and could also be funded through the District's Designated funds then leaving a balance of \$125,289.87.
