Local Farmers Win State Award for Protecting Water Quality

Lipman Family Farms (Kuzzens Inc. – Eastern Shore of VA branch) was awarded the Clean Water Farm award, a State award sponsored by the Virginia Department of Conservation and Recreation. It is awarded to Virginia farmers who implement nutrient management plans and are exemplary in their protection of the State's soil and water resources.

From the pool of Virginia Clean Water Farm Award recipients, up to 10 grand winners representing Virginia's major river basins are selected each year. Lipman Family Farms (Kuzzens Inc.) was nominated and submitted by the Eastern Shore Soil and Water Conservation District. Grand Basin Award winners must meet criteria of the Clean Water Farm Award and demonstrate exceptional conservation on the land and in managing operations. This award presents a chance to recognize farmers and land managers who use stewardship practices that benefit us all.

On behalf of Virginia Governor McAuliffe, Senator Lynwood Lewis and Molly Ward, Secretary of Natural Resources, presented Richard Davis and Aarin Nottingham of Lipman Family Farms (Kuzzens, Inc. – Eastern Shore branch), Virginia, with the 2016 Coastal River Grand Basin Award. Lipman Family Farms were recognized at the Virginia Association of Soil and Water Conservation Districts Annual Meeting on December 6, 2016 in Roanoke, VA.

Kuzzens Inc. now owns and leases approximately 4,000 acres of land in Accomack and Northampton Counties cycling a various rotation of tomatoes, corn, wheat, and soybeans. Lipman Family Farms operates over 10,000 acres on the East Coast and produces many vegetables including eggplant, melons, squash, peppers, green beans and citrus. Kuzzens Inc. is implementing a method of pesticide application using crab meal. The chiton from the crabs incorporated into the ground serves as an alternative target for nematodes-diverting their attention from the tomatoes. This significantly decreases the need of other fumigants. Not only does Kuzzens exemplify conservation stewardship through best management practices and voluntary efforts; they utilize innovative technology to open doors for more effective methods to minimize their ecological footprint in the local community.

Kuzzens Inc. maintains at least 65-foot buffers to separate their production lands from ditches and other water ways. Out of the 4,000 acres they own and lease for agriculture, roughly 1,300 acres serve as buffer systems. Mindful of water use, Kuzzens Inc. uses the Evapotranspiration system in their low-flow irrigation tape. All plastic is recycled, and Kuzzens Inc. reuse tomato stakes for up to 5 years. Providing over 1,300 seasonal jobs on the Shore, Kuzzens Inc. has a facility in Melfa, Virginia and a packing facility in Westover, MD.

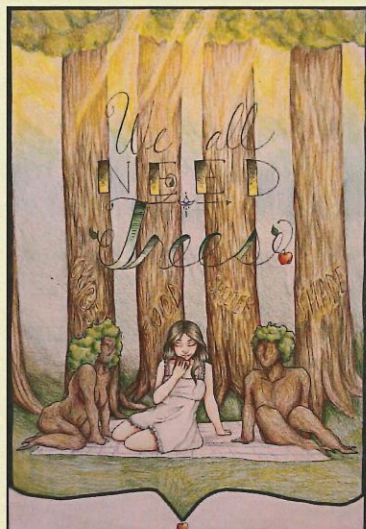
Two \$500 Fletcher/Beasley Scholarships Available

Youth Conservation Camp Scholarship Available



For 40 years, the Virginia Association of Soil and Water Conservation Districts has sponsored a week long summer conservation camp for Virginia high school students (currently enrolled in grades 9-12) on the campus of Virginia Tech, Blacksburg, VA. This year the camp will be held July 9-15, 2017. The program brings together about 70 interested students from across the State for a week of learning about Virginia's natural resources from conservation professionals and faculty from Virginia Tech. Most of the instruction is hands-on and outdoors.

The Eastern Shore Soil and Water Conservation District and Ye Accawmacke Garden Club are offering scholarships to send two Eastern Shore High School Students to the Youth Conservation Camp. During the week long camp, campers will learn about lake ecology, fisheries management and stream morphology through hands-on experiences. There will be tours of the Forest Products Center, Swine Center and Veterinary Teaching Hospital. If hiking to the Cascades Waterfall, swimming, fishing, tree and insect identification and canoeing sound like something you would enjoy, then this camp is for you! Apply by April 14, 2017. Robin Rich-Coates, District Chair Recognized for 25 Years of Service

Robin Rich-Coates was recognized for 25 years of service on the Eastern Shore SWCD Board by the Virginia Association of Soil and Water Conservation Districts (VASWCD). VASWCD presented a 25-year service pin commemorating her 25 years of public service to the District at the Annual Meeting on Tuesday, December 6, 2016 in Roanoke, VA.



Assistant to the Vice President of Academic and Student Affairs and Associate Professor of Biology and Chemistry at the Eastern Shore Community College, Robin was the District's first female board member. She was an ESSWCD volunteer since 1985 and became a director in 1991. She holds a B.S. in Biology from Madison College (now James Madison University) and an M.S. in Human Genetics from the Medical College of Virginia. Robin has always been active in local environmental education activities, including work with the Chesapeake Bay Foundation, the Virginia Institute of Marine Science, the Nature Conservancy, the Arbor Day committee, Endowment committee and the Environmental Education Council. Each year Robin coordinates the College's science fair for students in Northampton and Accomack public and private schools. The District Board and Staff appreciate Robin's dedication and commitment to the District for so many years.

Conservation Grants Available for Environmental Education

Are you or is your organization involved in environmental education on Virginia's Eastern Shore? Do you need funds to help provide these opportunities? Then you might be interested in applying for this grant by filling out the one page application form.

Wednesday, March 1, 2017 is the application deadline for the 2017 Billie Fitzgerald Memorial Conservation Grants from the Eastern Shore Soil and Water Conservation District. Schools, Scouts, Community groups and other organizations in Accomack and Northampton Counties are eligible for these grants.

Funding up to **\$250 is available** for projects such as outdoor classrooms and nature trails, recycling programs, butterfly plantings, storm drain stenciling, water quality testing, birdfeeders for the schoolyard, and field trips for environmental study. The Eastern Shore Soil & Water Conservation District Endowment Committee does not fund beautification projects, food or money for textbooks.
